Purpose of Meeting:

Understand expectations, goals, objectives and priorities. Identify key stakeholders

1. Schedule/Coordination

Discussion of events in Cheyenne that may pose conflicts with City Staff:

County Fair - August 4-11, 2007

Super Day - June 23, 2007

These dates could be opportunities for informational booths to educate public regarding Belvoir.

2. Site Visit

Helicopter tour may need to be budgeted into scope. Helicopter may only hold 4-5 people, so either 2 trips, or prioritize staff. Other staff will conduct site visit by 4 wheel drive vehicle.

3. Key Considerations

- The overall purpose of the plan is to create a balance between preserving resources and potential uses
- Because Cheyenne does not currently an open space program, the Belvoir Ranch Master Plan is an opportunity to set guidance for such a program.
- The Belvoir Ranch Plan will need to be formally adopted by the governing body.

4. Recommendations for Public Process

Website

• Make video clips of Belvoir available for introduction to site

Public Outreach

• Possible tours led by a season guide could be offered once a week to view Belvoir

Products of Success

- Identify existing conditions
- Land use potential
- Planning process should be open and frequently communicate with the public Belvoir is currently relatively unknown and inaccessible to the public.
- Plan to be informational
 - ♣ Inform public on issues and options
 - ♣ Format should follow PlanCheyenne but doesn't have to replicate the plan
 - ♣ The plan will be not so much as a report as a public relations document
 - ♣ Will be adopted formally by governing bodies
- Education
 - ♣ Open Space Programs
 - **♣** Biodiversity
- Potential for benefits of interpretation of historic elements
 - ♣ University of Wyoming could help with the archeological
 - ♣ Colorado has excellent planning regarding this on open space lands

Recreation Uses

- ♣ Trail system walking, hiking, and bicycling trails that create a connection to the City of Cheyenne, adjacent Colorado open space, and Wyoming parks and other recreational areas
 - Trail surfacing important due to high winds
- ♣ Scenic Drive one improved road through ranch for wildlife or livestock viewing and to allow all users access to the site.
- ♣ Equestrian use
- ♣ No overnight camping and no fires or alternatively use designated campground pad sites with no open fires

- ♣ Hunting of antelope and mule deer
 - Trail systems may not be a compatible use with hunting
 - Manages wildlife populations
 - Wyoming Game and Fish manages wildlife Aug 15 to Mid-Oct Antelope season
 - Hunting area located east of Harriman Road at western end, south of Interstate
 - Big Hole not currently part of hunting, there are mountain lions in this region
- ♣ All Terrain vehicle (ATV)/4 wheel drive vehicles preference is no motorized use as would necessitate constant patrol
- ♣ Snowmobiling not enough snow
- ♣ Links golf course as a possible recreational/land use

Other Land Uses

- Water resources avoid uses that conflict with water resources development, possible footprint from storage tanks, TCE groundwater contamination
 - ♣3 Groundwater sources currently being investigated
 - ♣6 new test holes with 12 to date
 - ♣ Ogallala Region Final Groundwater Report in August
 - ♣ White River Region Final Groundwater Report in June
 - ♣GIS mapping is available
- Landfill not top priority land use
- Grazing
 - ♣ Recently renewed a 5 year grazing lease
 - ♣ All of the Belvoir property is grazed with the exception of meadow at east end
 - ♣ Grazing is currenty13 Animals per acre per month
 - ♣ Big Hole not currently leased for grazing
- Conservation
 - ♣ Colorado Butterfly Plant has a population at east end of Belvoir along the riparian corridor
- Alternative energy development
- Wind
- Property will need to be platted prior to wind development

Education

- Atlas missile site ruins opportunity for preservation/education and national monument or historic site for its historic importance
- Biodiversity high plains grasslands and wildlife
- Opportunity to use Ranch Headquarters and homestead sites
- History: the site has prehistoric to historic elements

Transportation

- Public crossings WYDOT must approve plans for access, Dick Hartman is the contact for all UP railroads
- 14' underpasses under railroad crossings at creek designed for cattle movement between pastures all fenced and gated

Access

- 14' underpasses under railroad crossings at creeks
- Tie together proposed trails with Larimer County trails, City of Cheyenne trails, and looking at connections to surrounding parks and open space.
- Identify trailhead locations to access Belvoir
- Identify where and what to tie trail system together
- Scenic road across site

Zoning

- Currently no open space designation
- Property is currently designated agricultural
- Looking for Master Plan to come up with policies regarding zoning and uses

- Currently a steering group meeting quarterly
- Needs to be a balance between trails and ability to manage
